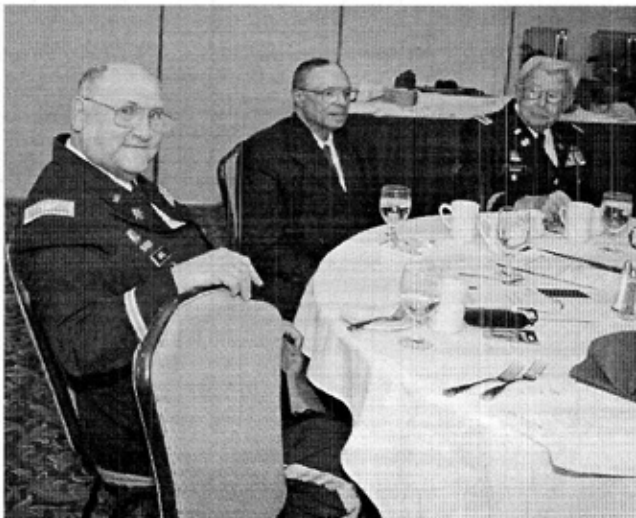

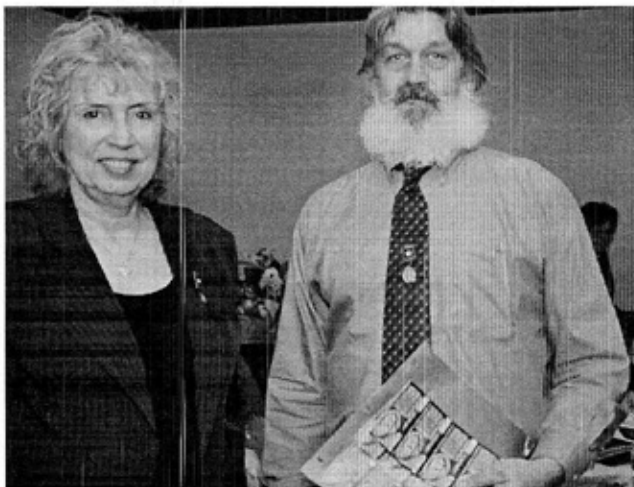

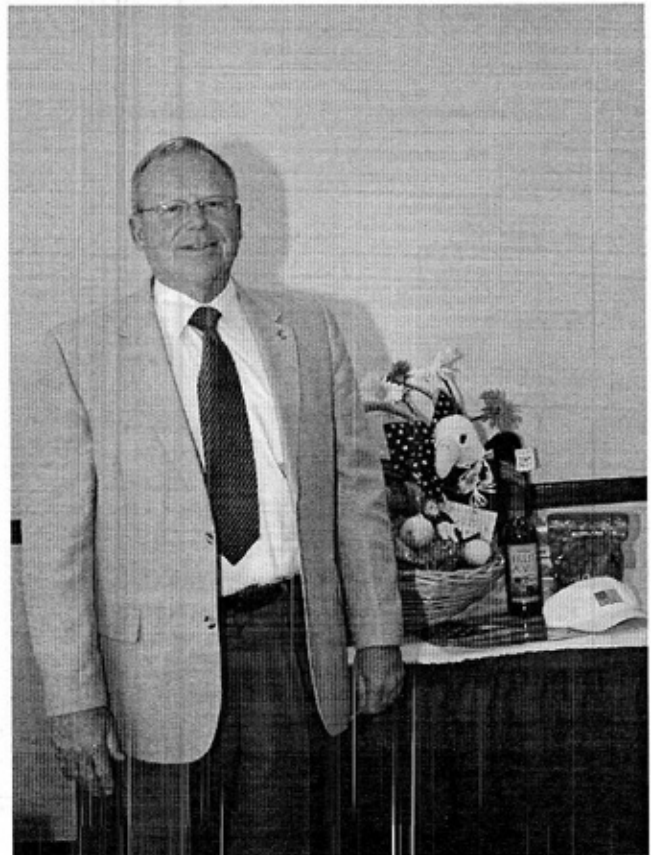

Whooze Nuze

Saw lots of Antelope, Bison and some Bears. We stopped in Thermopolis, WY to dig Dinosaur bones for a week. Very interesting and we enjoyed it thoroughly. BG Robert D. Upp Last 63rd assignment, Staff Judge Advocate. General Upp stated that when you reach my age, you spend a lot of time, reminiscing, and reliving pleasant times of the past. Some of my favorite memories are from the summer camps with the 63rd USAR Division from 1955 through 1964. Of course, it was sort of "old home" times for me, as during the Korean War, I was stationed at Camp Roberts for a year, before going overseas.

Joe Gedodi ran the greatest steak house in his small bar in the village of San Lucas, south of King City. Joe gave the place to his son, retired and moved to Italy. The son went broke in a year, the

place closed and is no longer in existence. C'est la Vie. There was also a juke box bar on the Jolon Road north of Hunter -Liggett. I went there sometimes on a weekend . I was at the bar one Saturday night, and this elderly woman came over and said that one of the soldiers told her that I was an attorney. So she told me her problem. Her former husband, angry because she was having an affair, took their nearly 4,000 acres and left it to tenants in common with her and six of his relatives. I told her to get a lawyer and have it partitioned. She said that she had been to three lawyers and none would take it. After some martinis, I said that I would help her. She asked how much I would charge and I said "some of the land". It took me six years, but I now have 84 acres in beautiful Crazy Canon, once the Camino de real between missions. We remained friends for as long as she lived. I seldom get up there, but I've had some wonderful neighbors who check things. The best was Amelia, she was born on the Italian/Yugoslav border and, as a teenager was injured by German shell fired during WWII. She was treated in an American hospital and married a young Captain she met there. They wound up in Korea. He dumped her for a local girl. She married a Master Sergeant and they were transferred to Fort Ord. She then moved out to be my neighbor. A local contractor started to run a bulldozer over her property and she sat in the lane on a tub with her shotgun and said if he crossed the line she would shoot him. That wound up with the sheriff, who said settle in court. The judge granted the builder an easement on condition that he maintains the road. She then got in trouble for going out under a mountainside tree at night, tying up a young goat as bait, and then shooting a mountain lion that had killed one of her goats. So she sold out and moved to her birth place, now in Italy. She built an apartment in part of her house and said that it was for Jane and me anytime we came over. We have visited her there four times.

Once, she was driving into Sloveni to get gas, \$5 in Italy, \$1 there. She asked me to go with her, but I said I had no Visa and Slovenia was at war. She insisted and when we got to the boarder, the guard kissed her and she gave him a carton of PX cigarettes. She died; last year. C'est la Vie. My

current neighbors are great. She is a school nurse. He is an Alaskan-Indian, retired shaman for American Indian in prison.

SGM Thomas Gorden, I am completely retired, but I am still doing volunteer work with the Employer Support of the Guard and Reserve (ESGR) as an Ombudsman. Thanks to all for selecting me to continue being your assistant secretary.
